And at our annual graduation party the graduates would always mention their sponsors when they gave their speeches of gratitude.

Irma is a 19-year old girl, born with spina bifida, who was a part of our learning center for children with disabilities. She just

Irma graduated from high school and is excited to attend university, hopefully this fall. Since she was small Irma has walked with bent knees, making it difficult to transport herself long distances. She walks with a walker.

With the help of Dirk and Mary Kos she was granted a chance to see doctors at Shriners hospital in Pasadena, CA. The first step was to get her a medical visa. Irma was very nervous about this as she had applied for a visa last year and was denied. This time she got help filling out the paperwork and Angelina, Irma and I took a trip to the US consulate in Tijuana.

We prayed for God's will to be done, that we would accept the results. It was a difficult prayer as we were hoping for a positive outcome, but we had peace that in the end the right decision would be made. I walked her into the consulate and we sat in the chairs waiting to be seen by the agent at the window.

Irma walked up to the window with her walker and spoke to the agent. She had all of the paperwork she was supposed to have with her, answered all of the questions succinctly and then in greater detail when asked and in the end she was granted a visa.

We left and did a little dance just outside of the doors. She started to cry in happiness and relief. Only a week later the visa was ready to pick up, meaning we could make the appointment that had been scheduled.

God knows what we need and his timing is perfect. She picked up her visa one week before her scheduled appointment. And to top it all off, she was granted a 10 year tourist visa, so she is able to cross the border for any follow up work.

On the 27th, I picked up Irma where she lives with her mother and two brothers. She gave her mom a tearful hug and we started toward the US. We talked about expectations, what her hopes were for this appointment, what she expected to see when she entered the US for the first time, things she was hoping to do or see once we got there. It was a good trip full of conversation and a lot of laughing.

When we arrived at the border you could see the nerves starting to take over again. She was worried the border guard wasn't going to let her come into the USA. I tried to explain to her that it's not a big deal, we weren't carrying anything illegal and she had all of the correct paperwork. We got up to the border and the guard took our paperwork. He asked why she was entering the US. I explained her need for medical help at Shriners and told him we were staying for two days. He said okay and to have a good time and we were on our way. Yet again God provided with a kind border officer who was able to put Irma more at ease.


We stayed in a hotel less than 10 min from the Shriners hospital, and arrived to our 10am appointment with plenty of time to spare. We saw both a pediatrician and an orthopedic surgeon, who checked out the flexion and extension of each of her legs. They had her walk with her leg braces and they talked to her about what kind of an outcome she was hoping.

In the end, the doctors do not believe she would benefit from, nor does she need to have leg straightening surgery. They believe they can straighten and strengthen her legs with the use of better orthotics. She was fitted for a new set of braces that we will pick up at the end of this month! It will be exciting to see how this improves her mobility.

What a great trip and what a blessing that there are people willing to sponsor this young woman in her quest to be able to walk more easily. We have so much to be thankful and grateful for!
